

**2011 Property Tax Rates in Palo Pinto County Hospital District**

This notice concerns the 2011 property tax rates for Palo Pinto County Hospital District. It presents information about three tax rates. Last year's tax rate is the actual tax rate the taxing unit used to determine property taxes last year. This year's *effective* tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's *rollback* tax rate is the highest tax rate the taxing unit can set before taxpayers start rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

=This year's effective operating rate	\$0.197912/\$100
<b>x 1.08</b> =this year's maximum operating rate	\$0.213744/\$100

**Statement of Increase/Decrease**

If Palo Pinto County Hospital District adopts a 2011 tax rate equal to the effective tax rate of \$0.197911 per \$100 of value, taxes would increase compared to 2010 taxes by \$56,806.
