FLEXIBLE PAYMENT SOURCES

- **MEDICARE**

Eligible Medicare patients must be home bound, under the direct care of a physician and need a Medicare reimbursed service. (skilled nursing or physical therapy.)

These services will be provided on an intermittent basis as ordered by your physician.

- **MEDICAID**

Prior authorization is required for Medicaid recipients. Care will be provided under the direction of your physician. The service will be provided on an intermittent basis

- **INSURANCE**

Some insurance companies provide home health coverage under the direct care of a physician. Deductibles and payments vary with each insurance company. Workman's Compensation may also be accepted upon verification.

- **OTHER**

We work with and are associated with many Health Management Organizations (HMO) All skilled as well as unskilled services can be provided on a private pay basis.
